



ccGEN2 Dealer Authorization Process

Dealers interested in selling ccGEN2 must be authorized, with at least one company employee certified. Select dealers will be approved by Volutone and URC sales personnel. Interested dealers will follow these steps to becoming authorized to purchase and resell ccGEN2:

1. Secure and *completely fill out* the ccGEN2 dealer application. This application is available from the authorized distributor.

a. Make sure that page 3 – *URC's ccGEN2 Customer Declaration Form* – is filled out in its entirety and submitted as part of the application in order to secure authorization.

2. **SUBMIT:** Dealer will submit the completed and signed application to Volutone for approval.

Submit all 3 pages of the completed application to Volutone via email or fax:

a. *EMAIL:* scan all three pages and email to: purchasing@volutone.com

b. *FAX all three pages to:* 805-581-7912

3. **PROVISIONAL APPROVAL:** Volutone Corporate must sign & date the application with their approval. Once Volutone approves the application, they will forward to URC for final approval.

4. **LEARN:** Dealer personnel must pass the certification requirements by completing the requisite training.

a. Training may be achieved via live, in person sessions at the approved distributor

OR

b. By completing the entire series of self-paced courses on URC University.

(Once completed you must submit URC Training Certificate and application via *EMAIL:* scan of training certificate to: purchasing@volutone.com)

5. **AUTHORIZATION:** Dealer is now authorized to buy ccGEN2 from the distributor the dealer has submitted the application to.

If the dealer wishes to purchase ccGEN2 from another distributor, they will have to repeat the application process – for every distributor they wish to purchase from.

6. **DEMO:** Dealer is *encouraged* to purchase demo system.
